Meanwhile, I want to share a few things I have learned while making this transition. <u>Elsewhere</u> in this edition I will go into more detail...please don't miss it.

Most of our new members join via the internet, which is great. When you recruit a new member, encourage them to fill out the form at https://discoveryowners.com/join.html. This assures all their information transfers into our membership files correctly and can also be used elsewhere. We encourage existing members to use that page to renew or make changes for the same reason - accuracy. If renewing, remember to make your payment separately.

Speaking of payment, PayPal is the preferred method and nearly everyone uses it (Thank You). However, it does not come without its own set of issues. All our records are tied to your membership number, but PayPal payments carry only the name of the PayPal account. We can usually match the payment to our records but it is a time-consuming manual process; It will really be helpful if you include your membership number in the memo section. The real challenge comes when the membership is in one name and the PayPal account is in another. In this case the member number is essential.

We are trying very hard to help everyone become current on their dues. Please understand if you receive (maybe multiple) "gentle reminders." Almost all of our members have responded positively, and we appreciate that.

Temporary Membership Coordinator (Continued) - Some Facts!

"I paid my dues" or "I applied for membership a couple of days ago so why can't I sign on to the DOAI website?" Or, alternatively, "I renewed but the website says I am still in arrears – why?" These and similar questions come up and we are happy to provide you with truthful, correct answers. Of course, to do so requires research, often more information, and sometimes communication with you.

A huge reason for these and related questions stems from a common misconception that because the membership application or renewal transaction was submitted on-line and paid via PayPal the downstream processes are all automatic and should be completed in near real-time. *Nothing could be further from the truth!* The transactions begin a **myriad** of both electronic and manual operations. Those operations are accomplished by a dedicated team of DOAI member volunteers who must balance these tasks with their careers, families, and other responsibilities.

Within a very few days of an application the Membership Coordinator will update the Master Membership Data Base with all the information the member provided. They will <u>manually</u> determine and update several additional data points. Two significant ones are the <u>membership number</u> (if a new member) and the "<u>next due date.</u>" Established members' number never changes. In a very few more days the Webmaster follows up with more manual operations. Those same two data points mentioned in the preceding paragraph are still not useable at this time. Wait – it is coming!

At approximately the 15th and end of the month the wheels turn and everything is completed, member-only pages, and "next due date" can be accessed by the member!

There are many other things these dedicated volunteers handle day-in and day-out such as <u>manually</u> accounting for all payments for the Treasurer and depositing any checks received via snail mail into the bank. We really owe them a debt of gratitude.

You can assist our volunteers and save lots of work if you will do a few things: (1) Realize that based on the calendar it will possibly take up to several weeks or so before a transaction should be considered as "not processed," so please allow time before raising questions. Not often but occasionally things do go astray and our research will find and correct them. (2) Once you have received your member number include it in any communication within DOAI. (3) If your question involves a payment, provide as much information as you can – when did you pay it, how did you pay it, etc. (4) **ESPECIALLY** if your PayPal account is not in the same name as your membership include your member number and name on your membership in comments when you submit your payment to PayPal. (5) If your PayPal account is in another name, include it in your question.

We are working hard to maintain accurate membership records. Thanks for "listening "and for your help.



sary to keep Herb and Sheri Rikelman Rides the rails at the trains running. Columbia State Park Jamestown Rail Town


has the remnants of an old gold mining ghost town and numerous gift



egistration for the national rally in Sevierville has been robust. We are expecting a large turnout, and we already have over 100 coaches signed up as of this writing in early June. With only 125 spaces available, the few remaining spaces will go quickly. The rally dates are arrival on Monday, 20 September, and departure on Sunday, 26 September. The deadline for registration is 23 August.

The Sevierville/Pigeon Forge/Gatlinburg region is a major tourist attraction area, drawing about 12 million visitors each year. The nearby <u>Great Smoky Mountains National Park</u> is the most visited national park in the country. From the many shops and restaurants to the excitement of the <u>Dollywood theme park</u>, there are unlimited entertainment options available in the area.

The rally is being held at <u>The Ridge Outdoor Resort</u>, an upscale RV and camping resort. Activities at the rally include three evenings of catered meals and professional entertainment acts. There will also be seminars and vendor days. Extra-curricular activities include a golf tournament, a Smoky Mountains bus tour, and several dinner theater shows.

When the original 2020 rally at this venue was cancelled, all registrations were refunded, and the roster was wiped clean. If you registered last year, your original registration was not carried forward. If you want to attend the 2021 rally, you will need to register again. Registration is being completed online, and payment is by check only, sent to the registrar. The base rally fee is \$655.00 for a 2 person coach, which includes campground fees, meals and entertainment. Golf, dinner shows, and the bus tour have additional fees.

Remaining spaces are limited, and time is running out for registration. If you are planning on attending the <u>2021 DOAI National Rally</u>, now is the time to sign up. Recollecting Summertime

Given our country's size, it is possible that your childhood and teenage summers were quite different from mine; one's experience could have varied depending upon where and when one grew up. A small town in southwestern Wisconsin was my birthplace. Summers were usually hot and humid. How we occupied those long-ago days as youngsters, then teens, is almost foreign to the way today's young people spend their summers.

Back then, we did not have television until well into the 1950s. Before that, we had radio. Those two inventions became our link with the outside world – they were mechanisms whereby, in the summer, we could listen to and then watch professional baseball games; we could let our imaginations roam while listening to various programs aimed at teenagers; we could dance along to the music being broadcast from some venue far away, or pretend being part of the live audience at an Elvis performance. Ah, yes!

During the summer days, however, we were outside as much as possible. In our small town, as in many small towns across the country, the younger kids usually went outside as soon as breakfast was finished, only to dash back in for lunch, and then out again until the five o'clock whistle blew – ours was at the co-op creamery – a whistle that was easily heard all over town. It was a reminder that no matter what we were doing, or in what activity we were involved, we had to beat it home or else (the "or else" could be a scolding or no dessert, etc.).

As my girlfriends and I entered our teenage years, many of us spent leisurely afternoons at the city park, swimming a bit and then relaxing in the sun as we lay on our bath towels, hoping to acquire a tan. We would slather our legs and arms with baby oil that was lightly colored with Mercurochrome (yes, I know that was bad) and then we would literally fry in that hot summer sun. It was "common knowledge" that the combination would prohibit a sunburn and enable one to become beautifully tanned (oh, the vanity of teenage girls and the silly things they believe!).

Those raised on a farm, however, could not spend their summer days in leisure. There were cows to be milked, crops to be hoed and watered, weeds to be pulled, and later on, harvests to bring in. The farm kids were not able to have the kind of summers we town kids enjoyed. My husband recalls his summers on his uncle's farm, working in various ways. His tan was acquired by doing something beneficial.

Remembering those days helps us to be grateful we are in the present, and that we have the health, financial means, and a Discovery motorhome in which to travel. May you have a grand summer!
