Summary of Board of Directors Meetings

e had three Board
of Directors
meetings while
at Lazydays with the
following attendees at
each meeting: Phil
Yovino, President; Mac
McIlvaine, Treasurer;

Tom Fields, Executive Vice President; Pete Pizzano, Rally Master; Joyce Bednarczyk, Secretary; Garry Shirey, VP South Central; Jim Devine, VP Southeast; Dick Snyder, VP North Central; John Baker, VP Northeast; Nina Soltwedel, Editor, *Discovery* Express.

Phil Yovino presided over each meeting. Phil expressed appreciation and thanks to Pete Pizzano, former VP Southeast Region, and the Florida Rolling Gators for their work and presentation of a good rally.

Following is a consolidation of items discussed and action taken at the board meetings:

- Obscovery Express: Print 2300 copies; mail 1500; 400 to Fleetwood to put in each new Discovery; 400 to be distributed to regional vice presidents for use as they think best (to dealers in their area or to prospective members). The next Discovery Express to be printed on white paper as a trial; let us know what you think.
- Club membership: How to prevent dropouts and retain current members. Board members to call dropouts for three-month period to determine reason for leaving. Action: we now offer 1-, 3- or 5-year renewal options at reduced fee: 1 year at \$16; 3 years at \$45; or 5 years at \$75. There will be a \$4 administrative fee for new members for the first year only.
- **Club chapters:** No limit to number of chapters in a region. Members can join any chapter, any region in compliance with chapter bylaws. Executive VP reported on meeting with chapter presidents, indicating their concerns on how to recruit new members and keep current members. They suggested officers and the general membership try to sit at tables other than with their close friends in order to get better acquainted and to make the first-time attendees feel welcome. Chapter presidents still want to sit in on board meetings. Action: Executive VP and/or his

alternate are to meet with the presidents as soon as possible following board meetings so they are informed immediately of board action.

- Mational rally: How to improve...
 more things of interest for women
 such as, craft classes, Red Hat Society, recipe exchange, etc. Offer CPR
 training or defensive driving class.
 Post schedule of events for rally on
 the Internet. Put two copies of schedule in the welcome bags. Encourage
 members to post emergency contact
 and health information in their
 coaches and in their wallets.
 - Secretary's report: All board meeting minutes will be e-mailed to the president, and he will forward to all board members for their response, corrections or acceptance. The board meeting summary also to be sent to the president and board members for approval. President to advise of acceptance prior to publication in the *Discovery Express*.
- **Treasurer's report:** The treasurer submitted copies of the 2003 and 2004 budgets, income and expense statement and DOAI 2003 net worth statement. Approved as submitted. Proposed change to standing rule C. for membership chairman revolving fund of \$500 to cover expenses incurred during normal day-to-day duties of that office. Proposed resolution to remove Bob Baugh signature from and add Phillip Yovino signature to the two accounts with First Bank of Livingston, TX in the name of DOAI. Both motions carried. Annual audit of books conducted on January 29, 2004. Auditors declared the financial records were in good order and fairly represented the financial condition of the DOAI for the year ended December 31, 2003.
- Northeast VP submitted budget for national rally to be held in York, PA in August 2005. After discussion it was determined that it was a well-planned budget and appeared to be sound and reasonable. Motion passed to accept the budget. ❖

Comments by Mac: This statement puts a dollar value on what DOAI is worth at the end of 2003. The \$500 revolving fund for the membership chairman compensates her for the period of time between incurrence of expenses and the time she is reimbursed. The MotoSat DataStorm System is used by Bob Cook, our webmaster, to maintain the DOAI website. The Sedalia rally receivable is a deposit for the fairgrounds in Sedalia, the site of the 2004 national rally.

Under liabilities, the rally account represents funds derived from profits from previous rallies, which will be used to support future rallies.

Audit of 2003 Financial Records *Comments by Mac:* The annual audit was conducted on January 29, 2004, by three DOAI members appointed by the president, in accordance with Article VII.F of the bylaws and standing rule #8. At the conclusion of the audit, the auditors declared that the financial records were in good order and fairly represented the financial condition of DOAI for the year ended December 31, 2003.

Auditors were Glenn Camp, a longtime DOAI member and the proprietor of his own business; Jim Devine, a member of the DOAI board; and Dorothy Devine, a past DOAI treasurer.


Discovery Pioneers, the other chapter in this region, has four rallies planned this year, including one in Branson, Missouri the week before the national rally in Sedalia.





uring the general membership meeting at the Kennewick, WA national rally last September, several questions from chapter presidents

surfaced. The ensuing discussion made it apparent that we need better communications between the grassroots chapter presidents and our national board of directors.

A subsequent meeting of chapter presidents was held with representation from five of the ten DOAI chapters: Discovery Pioneers, Discovery Texans, Nor'easters, Northwest Adventurers, and Texas Disco Road Runners. Two proposals from this meeting were presented to and unanimously approved by the DOAI board:

◆ Formation of a standing chapter presidents advisory council to

meet at regional and national rallies for crosstalk on topics of mutual interest, and to afford more direct interchange with the DOAI board.

 Publication of toll-free phone numbers assigned to DOAI officers in the newsletter and on the website to enhance communications.

The first scheduled meeting of the chapter presidents council was held at Lazydays in February with eight of eleven chapters (one new chapter since Kennewick) represented: Discovery Pioneers, Discovery Texans, Dixie Travelers, Florida Discovery Rolling Gators, Mid-South Roadrunners, Midwest Discoverers, Nor'easters and Texas Disco Road Runners. Tom Fields, Discovery Texans president and DOAI Executive VP, was elected to serve as chairman of the council. Jim Devine, DOAI founder and Southeast Region VP, was elected to serve as alternate backup to Tom. General discussion

covered a number of topics and several good ideas were offered focusing mainly on:

- Reaching new Discovery owners and attracting them into DOAI.
- Ways to maintain interest and keep members in the organization.
- ♦ Making first-time rally-goers feel welcome and important.
- Publicizing chapters and their activities and attracting new members.
- ♦ Ways to encourage and assist in formation of new chapters.

We plan to continue to work toward improvements in these areas to help the DOAI grow in numbers and in member interest and responsiveness. 3 bananas, mashed

1/3 c. lemon juice

1 c. sugar

1 20-oz. can crushed
pineapple and juice

1 16-oz. box frozen strawberries

2 c. orange juice

2 c. 7-Up® or Sprite®

Mix togther well and pour into 4-oz. serving dishes or plastic cups. Freeze. Let set out about an hour before serving.

Cheese and Bacon Frittata

6 eggs
1 c. milk
1 green onion, minced
2 T. butter, melted
½ t. salt
½ t. pepper
4 oz. shredded Cheddar cheese
2 oz. crumbled cooked bacon

Preheat oven to 400°. Grease 10½" round au gratin pan or 9" by 9" baking pan. Whisk eggs, milk, onion, butter, salt and pepper until well blended. Pour mixture into pan. Sprinkle cheese and bacon on top. Bake 20 minutes or until set and golden brown. Serves 4-6.

Hot News on WiFi Hotspots

ollowing up on Leo Everitt's informative WiFi article in the last issue, more and more RV parks are getting on the WiFi bandwagon. If you want to download a listing of parks with the service, go to www.rvtravel. com/wifi.html. RV Traveler's site was also mentioned in the "Helpful Internet Links" in the last issue, and the WiFi listing is just one small part of that interesting site. The listing of RV park hotspots is updated periodically, so checking back occasionally would be a good idea. Keep in mind that most of these hotspots are not free; however, if you are in dire need of checking your email and there's no other easy access, it may well be worth the hourly, daily or weekly rate for the ease of operating from your own rig.

Many have noticed that Flying J terminals also have hotspots. If all Flying J locations are not currently offering this service, it is most likely to be so within the next year. Unfortunately, these are not free, but the price is reasonable. Many Starbucks cafés offer hotspots, as well as McDonalds sites in San Francisco, Chicago and Seattle. KOA was attempting to have 200 WiFiequipped parks by the end of 2003, and many airport lounges and major hotels are also offering the service.

At the end of the RV Traveler article, there is a box where one may sign up to receive one or more of their free e-mail newsletters. "RV Travel" offers helpful news, information and advice for all RV'ers; "Florida RV'ER" is for anyone who travels by RV in the Sunshine State; and "Fulltime RV'ER" covers issues of interest to RV'ers who travel full time or who want to. The site promises to never share nor sell your email address. The site also requests that you let them know if you find an RV park hotspot not listed so that they can add it to the list. After Leo's article was published, I advised them of the sites he mentioned, and sure enough, those sites are now included.

DOAI Hotspot

The DOAI Hotspot is a WiFi (802.11b) connection for Internet and e-mail access that you can use for free at selected DOAI rallies and also on the road wherever you see Bob Cook in his 1998 burgundy Discovery 36T (look for a big satellite dish on the roof and a DOAI sticker on the windshield). All you need is a computer with a WiFi card (802.11b or 802.11g). At most rallies, the hotspot will run in unsecured mode, which means that all you

have to do is turn your computer on and connect to the Discovery beacon.

If Bob is not at a rally but you see him in a campground, just come on over with your WiFi MAC address and he will get you connected immediately. Due to the somewhat limited range, if you can't connect from the comfort of your D, either come on in for a cup of coffee or use your laptop outside on the picnic table. As always, if you are having problems, Bob will be glad to help.

Bob will be at the national rally in Sedalia, Missouri, this coming October.

DOAI eGroup Conversations

DOAI has an active and extremely helpful online eGroup. Each issue we will share with all of you some of the helpful conversations taking place. While complete solutions may not be involved, some of the exchanges may help D owners in the maintenance and enjoyment of their rigs.

Dick Owens wrote:

I found that my propane was shut off, so I checked the shut-off switch at my rear fill point. I found that one of the wires on back of the switch had corroded off. This happened to the other wire a short time ago, so that was the first place I looked.

I purchased a new switch and installed it with new connections and still no propane. In the fuse panel in the inverter compartment on my 2000 37G, I found two 3-amp fuses labeled "propane detector" and one of them was blown. I replaced it, and still no propane.

Does anyone know if there is a specific fuse for the propane shut-off and if so, where it is located?

Peter Shaffer responded:

Make sure that the propane detector has been reset by turning it off and on again. On mine (1997 36RS), the hot wire runs from the battery to the detector, then to the solenoid valve. I think that the detector has two hot wires; one wire is from the coach batteries and the other is from the chassis batteries (at least, that is what I was told). Make sure you have 12 volts on both red wires at the detector.

Dick responded:

Thanks to everyone for the help. I had several private responses as well as Peter's and it became very clear that there is a lot of difference between year model coaches. It appears that my 2000 37G is wired differently and my propane detector does not shut off the solenoid at the tank, and has no reset; it detects only. I have a separate shutoff switch at the back of the coach, beside my fill connection.

My solution was, I convinced myself that the problem was a broken wire. After splicing part of the wire between the fuse and the emergency shut-off switch at the rear of the coach and still not working, I finally took it to my favorite repair shop, and I was right...broken wire. This same circuit had a break in a wire close to my tank underneath the coach.

Presto! Ten minutes later we were back in business.

Cell Phones

he cell phone ads are everywhere

– usually lots of hype,
with little substance
for the consumer to make
an informed decision. The
cellular landscape changes
almost daily, so I can't
give you recommendations, but I can give you some guidelines to help you make an informed
purchasing decision.

Choosing a Cellular Provider

You want your cell phone to work when you want to use it. You will also find that your neighbor's cell phone may work fine, and your cell phone indicates "No Service." The problem is that there are two competing digital standards and they are not compatible. To make matters worse, some cellular providers operate at 1900 MHz and some operate at 900 MHz. Bottom line – check a cellular provider's coverage map and make sure they have coverage where you expect to be.

The next most important thing is to compare rate plans. There are usually many options, but if you travel a lot, you will want a rate plan that allows you to use your phone anywhere – and on anyone's network – without incurring additional roaming or long distance charges. You must be very careful here as some rate plans charge

a substantial amount for calls that are not made from their network. Next, find a plan that gives you the most minutes for the least cost. Most plans will also give you "free" minutes on weekends and at night during the week (usually after 9 p.m.).

Do you want data?

Most RV'ers probably also want to use their cell phone with their computer for e-mail and Internet access. The exciting thing here is that most areas of the country are converting to high-speed data access (usually from 144 to 256 kbps). This higher-speed data capability is often referred to as G3 or G2.5.

Again, you should check the coverage maps for this type of service. Also, check the rate plan as some providers will charge you based on the amount of data sent and others will just lump your data minutes into your total access minutes, avoiding a hefty data surcharge.

When comparing prices, also ask if a separate ISP fee is required as some providers act as the ISP, thereby eliminating monthly charges to AOL, etc. (Note: Most do not operate an email service, but you can get premium e-mail service from Yahoo and Hotmail for less than \$2/month.)

Choosing a phone

You will want to compare size, ease of use and battery life (talk and standby modes). However, if you will use your

phone in remote areas or also for Internet access, you will want to make sure that your phone has an external data connection to your computer, has a connection for an external antenna, and also a connection for an external AC power supply **and** that all of these can be used at the same time!

Some phones will only connect to Internet in digital mode. This means that you will not be able to connect to Internet unless the cell site has been provision-

ed for this special data access. You may want a phone that is also able to connect via analog. Although analog is a lot slower, it is better than no connection at all. Steer clear of the phones that only connect to Internet via analog, as they will soon be worthless.

You will generally want to steer clear of the faddish phones that also incorporate a camera. The camera feature is generally low quality and you will pay a premium to send the pictures to another phone.

information stored in the program. It has Flying J locations, as well as places such as Camping World, Home Depot, Wal-Mart, and almost every campground that is in our book. We even found all of the National Forest locations and the Corps of Engineers campsites we wanted as well. Sharon wanted to find a *Kids R Us* store (our first grandchild was on the way) while we were driving down the Interstate,

and presto, it listed one at the very next exit.

Want to find an RV dump and there isn't a Flying J nearby? Well, it also has them. Need a place to eat? Most restaurants are listed, as are hotels and airports. It even has listings showing telephone area codes. The Import Custom Places Wizard

enables you to import addresses from your Microsoft Outlook Contacts database, an Excel file, or text file. The program won't let you get lost for very long. If you miss your exit because you were singing to your favorite tune on the radio and not paying attention,

don't worry, *CoPilot* will give you a new route within seconds.

However, it is missing a few things. Interstate rest areas are not included in the 2003 version, nor are exit numbers shown in the display directions. It would be nice if one could simply tap one of the function keys and the next rest area would show up with the time of arrival shown. I also wish it had phone numbers and ZIP codes for the extensive listings. As it is now, when we pull up a campground that is nearby in the CoPilot program, we have to look up the same campground in the campground book to get the phone number if we want to check for availability and price. Also, the spelling leaves a lot to be desired. Want to find Wal-Mart? You had better just type in "wal" and do a global search. I have found Wal-Mart spelled "Wall-Mart," "Wal Mart" and "Walmart." Believe you me, if you misspell a word you are looking for, you won't get any hints as to the correct spelling. The help information indicates that you should spell out all place names and not abbreviate, such as "st" for "saint." But, if you look up "Saint Pat's High School" in Maysville, Kentucky, you won't find it. It is listed under "St Pat's High School." Go figure! Another complaint is the voice they use for the verbal instructions. I think a voice like Jeanie on "I Dream Of Jeanie" saying, "Yes, Master!" would be more to my liking!

The newly-released version of this program called *CoPilot Live 7.0* has some new features the 2003 version doesn't have. *CoPilot Live 7.0* can transmit messages between vehicle and home or office, with two-way messaging, vehicle location and itinerary updates. It also has Street-Level Maps of Canada and Europe.

Needless to say, I am glad I invested in *CoPilot*. The program is probably the most expensive of the popular GPS programs out there; initial cost is somewhere around \$360 and yearly updates are running around \$99, but the wealth of its data base is overwhelming.

Maintenance Tips from Freightliner Radiator and Charge Air Cooler Maintenance

On chassis equipped with a rear radiator, it is very important that the radiator and charge air cooler be inspected at regular intervals. Cummins® recommends inspecting the charge air cooler every 7,500 miles. This should also apply to chassis with Caterpillar® engines. This is because air and dust are being blown through the radiator and charge air cooler and can build up and reduce the airflow through the cooling system. This is considered part of normal maintenance.

From the engine side of the radiator, use a flashlight to look into the fan shroud at the face of the charge air cooler. If there is any dirt buildup, this should be cleaned, using a water hose and a mild solvent. If this is not done, the system can become clogged and can result in engine overheating.

Engine Compartment Maintenance

When camping in remote areas, check the engine compartment for small animals that may have taken refuge for the night before starting your engine. They like the warmth of the engine compartment but will make a real mess if you start the engine while they are nestled in the fan shroud.

Preparation for Storage

When storing your motor home for an extended period of time (60 days or more), the following steps should be taken to give it maximum protection:

	Fill fuel tank and add a high-quality fuel stabilizer to the fuel (never store with a partially full tank of fuel). Change the engine oil and filter (used oil does not give adequate protection).
	Cooling system was originally protected with antifreeze to -34 degrees F. If colder temperatures are
	expected, adjust the mixture. If coolant has been in the vehicle for five years or 100,000 miles, flush the cooling system and fill with an appropriate mixture of
	antifreeze and softened water, and be sure that the coolant contains a rust inhibitor.
	If it has been more than 18 months or 24,000 miles
	since the transmission has been serviced, change the fluid and filter.
	Service the fuel filters.
	Run the engine until fully warmed up.
	Operate the air conditioning.
	If possible, store the vehicle in a dry, well-ventilated
	area, protected from sunlight. Check tires for damage and set tire pressure to
	maximum as indicated on the sidewall of the tire.
	Clean the tires using the normal, mild soap that you would use to clean your RV.
	If possible, raise the vehicle onto safety stands. Do not
	store the vehicle on the hydraulic leveling jacks.
	Hydraulic jacks will "bleed" pressure over time,
	lowering the coach back onto the tires.
	Cover tires to protect from heat and sunlight.
	If possible, release the parking brake.
	Remove and clean the battery. Always disconnect
	the negative (-) cable first. Store the battery in a
	cool, dry place and keep it charged .
	Lubricate all grease fittings on the chassis and
	drivetrain.

When removing your motor home from storage, the following steps should be taken to give it maximum protection:

 Remove covers from tires and thoroughly inspect the
tires for damage. Inflate them to the correct pressure
for the actual weight on the tires. Consult the Miche-
lin® Tire Guide for correct tire pressure. Weigh your
coach if you don't know the coach weight.
 Check for fluid leaks. Repair as necessary.
 Check engine oil level. Add oil if needed.
 Check coolant level in reservoir and radiator (do not
open radiator cap on hot engine).
 Check hydraulic fluid level in reservoir. Add fluid if
needed.
 Check engine belts for wear, damage or cracking.
 Check engine fan for damage.
 Check fuel/water separator. If empty, prime fuel
system per instructions in your operator's manual.
 Check engine compartment for nesting animals.
 Check for leaks and damage to hoses and wiring.
 Check rear-axle lubricant level.
 Lubricate chassis and drivetrain.
 Check the charge level of the battery. Clean ends of
battery cables. If batteries need to be removed or
replaced, install a clean and fully charged battery.
Always connect the positive (+) cable first and
then the negative (-) cable. Coat the battery terminals
and connectors with a protective sealant.
 Turn the ignition to the RUN position. Verify that the
fuel gauge and voltmeter are operating properly.
 If stored on safety stands, lower vehicle at this time
and set the parking brake.
 Run engine until warm. Re-check for fluid leaks.
 Check transmission fluid level using the Cold Check
method in the Allison® transmission operator's
manual. Add fluid if necessary.
 Check all exterior lights, and replace as necessary. �

One Man's Fix

had a problem with my slide marking the floor. I devised a fix and posted the solution on the DOAI website. Recent eGroup messages indicated several members were having the same problem. I hope my solution proves helpful.

The edge of the floor of the slide in my coach deflects downward enough so that it rests on or comes in contact with the tile floor during travel, and marks the floor with what looks like aluminum oxide – a black deposit. It has done this since essentially new. I had some conversations with other D owners and with a dealer service manager, none of whom gave acceptable guidance (the service manager suggested returning to the factory for what sounded like major work, which did not appeal to me).

My solution to prevent the marking was to put spacers between the tile surface and the bottom surface of the retracted slide platform, as follows:

 After retracting the slide, I slip the tip of a thin and broad (2" wide) pry bar between the tile surface and the Continued on next page...

bottom surface of the slide platform at the edge of the slide floor (which is carpeted). The location of the pry bar is just rearward of the projecting corner of the dinette portion of the slide platform – the forward edge of the pry bar is 2" rearward of this corner. This location is about mid-span of the slide assembly.

- 2. **In order to** get the tip of the pry bar underneath the slide platform, I bump the other end of the pry bar with enough force to move the tip about 1/2" to 3/4" under the platform. This lifts the platform 1/4" to 5/16".
- 3. **I place two** rubber spacers between the tile floor surface and the bottom of the platform, one just forward and one just rearward of the pry bar, far enough underneath so that they will support the platform.
- 4. The spacers are round and flat about 7/8" in diameter and 3/16" thick. They are made of slightly soft rubber, and can be sliced off rubber stoppers available at Home Depot, etc. To cut the rubber, I use a sawing action with a sharp knife blade and I lubricate the cutting action with liquid detergent.
- 5. **With the spacers** in place, I pull the pry bar out from beneath the platform, allowing the weight to transfer to the spacers.
- 6. After the day's drive, before extending the slide, I replace the pry bar under the slide platform, located as above. While pushing downward on the lever end of the pry bar in order to lift the platform off the spacers, I use a retrieval tool made of more-or-less 16 gauge wire to move the spacers out from the platform. The wire tool has a semicircular hook which goes behind the spacers in order to pull them out.

Each operation – placing and removing the spacers – takes about one-half to one minute. Any questions? Please let me know at seecarrollsgo@ aol.com.

You Can Run, But You Can't Hide by John Veach

s full-time RV'ers, we travel to all corners of our great country. Friends and family asked us, before we headed out almost five years ago, to let them know from time to time where we were. To that end, we have installed a tracking system in our Discovery that allows folks to follow us as we travel.

As amateur radio operators (hams), we have access to the Automatic Position Reporting System or APRS. APRS was developed by a ham radio operator to allow people to track each other using the Global Positioning System or GPS.

The requirements for using APRS include at least a Technician Class Amateur Radio license. This license has never been easier to acquire. The license requires a simple test of mostly rules and regulations of the Amateur Radio Service and it no longer includes a Morse code test. In fact, the Morse code requirement has been deleted from the amateur testing in many countries around the world. The United States is reviewing the need for Morse code testing for the other two classes of amateur licenses in this country right now.

At this point, there are three classes of ham radio licenses in the U.S.: the Technician (requires no code test), the General and Extra Class licenses. The last two require a five-word per minute Morse code exam at the present time. While one can use APRS with any of these classes of ham radio licenses, the Technician is the entry class and is by far the easiest to acquire.

You can find a location for taking this exam by logging on to the American Radio Relay League at www.arrl.org. The ARRL is the largest entity representing ham radio interests in the world. They have books to help you learn the basic information needed to get your Technician license (or any other class of license). They also can help you find a site where local ham volunteers (VECs) will administer your exam

After you acquire your ham radio license, you will be assigned a call sign. My call is KE4D. With your license and some simple equipment, you can then get on APRS and allow folks to track you via the Internet.

If you go to www.findu.com/cgibin/find.cgi?ke4d, you will see my APRS signal and my location. I have a Delorme Tripmate GPS receiver that sets on the top of my TV inside my Discovery. That GPS feeds a signal to a ham radio I have installed in the front of the D. The radio beacons my position as provided by the GPS out on the Amateur two meter band.

When we are sitting as we are now, in Okeechobee, Florida, I beacon every 30 minutes. An Internet gateway ham radio station then picks up this signal. There are hundreds of these scattered around the U.S. This station in turn, sends my position information to a website at www.findu.com. The web server there posts my position on a map at the exact GPS coordinates provided by my GPS

receiver. You can even call up a

country with APRS.

satellite photo of many parts of the

When we are traveling, I beacon every three minutes and you can actually see us moving down the road. The report gives our speed, direction and altitude. Many times, we have received e-mail from folks who saw us as we traveled through their town or county.

Other than a small fee for the license test and the cost of your GPS and ham radio equipment, this is a free service. The radio equipment needed is a two meter radio and a terminal node controller, or TNC, along with a GPS. My particular radio has a built-in TNC and APRS software included, so I have just the radio and GPS to utilize this feature.

APRS allows our children and grandchildren to know exactly where their wandering parents and grandparents are in real time at any given moment. It provides the same information to other ham radio operators in the area in addition to thousands of folks who see us on the Internet. We have had numerous visits from folks who have seen us on APRS and stopped to see us.

APRS is a great way for your family and friends to keep up with your travels, and ham radio is a great hobby for anyone. If you are interested and need more information, feel free to email us and we will try to help you get started.

Discovery "Souper Bus" Travels to Promote Charity by Dan Fletcher In the last issue of Discovery Express we shared with you Dan's article on how his 38' Discovery was wrapped in bright fleet graphics for a 10-cities-in-10-days tour to promote the 15-yearold nationwide youth-led movement, Souper Bowl of Caring. Here's his follow-up report:

n January 22, we had the honor of serving at the Capital Area Food Bank with First Lady Laura Bush. She packed and sorted food with young volunteers in the food bank and delivered a short address asking all Americans to join the Souper Bowl team. Before Mrs. Bush's arrival, the Souper Bus was swept (that's Secret Service-speak for thoroughly searched) by members of the Secret Service, both human and canine.

The following day we visited the St. Anthony Padua School in Baltimore, then headed south. Our next stop was the food bank in Raleigh. After sorting food in the Food Bank of North Carolina on Saturday, January 24, we boarded the bus and headed back to our home base in Columbia, South Carolina to continue the southern leg of our journey.

While we had no trouble with winter weather in the north, an ice storm proved to be our undoing in Charlotte and Columbia, where both events had to be cancelled. Determined to keep our schedule at the Jacksonville, Florida food bank on January 27, we headed out of Columbia on January 26 while the ice storm continued to worsen. Just south of the I-95/I-26 confluence in South Carolina, the freezing rain turned to rain. Florida temperatures the next day were balmy.

We participated in a press conference at the Food Bank of Northeast Florida where they announced a task force to promote the Souper Bowl of Caring in 2005, when the big game will be played in Jacksonville. Then we headed west on I-10 for Mobile, Alabama. The next day we visited the Little Flower Catholic School and the Trinity Land Day Care Center. The school issued a challenge to other schools to participate in the Souper Bowl of Caring while the day care center fed all on board the Souper Bus homemade soup.

Heading across the bayous and swamps of Louisiana, we arrived in New Orleans by late afternoon on January 29. The Souper Bus crew, except for the driver, stayed in a



downtown New Orleans hotel. The hotel staff made arrangements for the Souper Bus to park on the street. We had to fold in the drivers mirror to make sure it wouldn't be hit by the passing streetcar. The next morning we enjoyed beignets from the Café Du Monde in the French Quarter before working at the Second Harvesters Food Bank. The final leg of our Blitzathon journey was from New Orleans to Houston, Texas arriving in Houston January 29. While in Houston, we parked the Souper Bus outside of the convention center, where frenzied activity for the upcoming game was taking place. The Carolina Panther cheerleaders were there and posed for a picture beside the Souper Bus. The colorful bus attracted lots of attention and people even knocked on the door to make donations to the Souper Bowl of Caring

On Friday night January 30, cheering young people greeted the Souper Bus as we rolled into the Houston Food Bank to volunteer. On Saturday, we made the rounds to several churches collecting canned goods in a citywide food drive that gathered over 40,000 pounds of food and \$40,000 for area food banks and pantries. Totaling these figures and using Houston Food Bank conversion charts, this translates to over 1.5 million meals to feed those who are hungry.

Reports continue to come in from participants in Souper Bowl of Caring 2004. As of March 10, over 12,000 participants have reported collecting \$4,116,443 to help the hungry and hurting in their communities.

My wife, Anne, flew to Houston to make the drive back to our home in

Columbia, South Carolina. We plan to leave the wrap on for a while longer before transforming back to our regular Fleetwood Discovery. The wrap has to be heated and then removed by Bumper2Bumper Media, the company that donated the graphic wrap for the Souper Bowl.

To check the Souper Bowl of Caring totals or to get more information on how you can get your organization involved visit www.souperbowl. org. And if you see a brightly colored bus with giant teenagers, don't forget to honk.

If you belong to a faith community, how about proposing to your congregation's youth group that they get involved in this helpful and meaningful endeavor for 2005? It's a great way to help those who need our help, and it just plain feels good to know that somewhere, someone may not be as hungry and perhaps have a bit more hope because of our sharing.

Campground Memberships

ost RV'ers soon look for ways to lower their nightly camping costs. There are many camping "clubs" that tout great savings if you belong to their system. The purpose of this article is to help you with some guidelines and tips so that you can make an informed decision.

Types of Memberships

There are basically three types of campground memberships – campground associations, membership clubs and discount networks.

Campground Memberships, cont.

One type, the campground association, typically requires that you have a "home park." This usually requires that you pay an initial fee to join, an annual "maintenance fee" to your home park, and annual dues to the national organization. Members get to camp for a set fee per night with typically a oneor two-week maximum stay. Usually, only ten percent of the total spaces in a campground are available for member RV'ers to camp at the discounted rate, so reservations are usually necessary. Campgrounds are individually owned and operated. The initial fee and annual maintenance fees vary widely between member campgrounds, so you should always shop for the best deal. An example of a campground association is Coast to Coast, and the number of member campgrounds can be upwards of 400+. Note also that there is a lot of turnover in the member campground system as existing parks may leave the system and new parks join the system.

Another type is the membership club where all the campgrounds are owned and managed by a single company. You may also have a "home park," and you will have to pay an initial fee to join and annual maintenance fees. In exchange, you may get a certain number of "free" nights and/or a set fee for additional nights. Some clubs have contracts that obligate you to remain in the system for a minimum number of years unless you sell your membership to another person. Your length of stay is usually limited, after which you must leave for a predetermined time before coming back into the same park (and sometimes the same system). Reservations are usually recommended during the busy season. Thousand Trails is an example of a membership club, and typically you will find well less than 100 campgrounds in the system. This is usually the most expensive option in terms of up-front and maintenance

The third type of membership is a discount network. This type of membership only requires an annual member fee to the national organization, does not require home park initiation or maintenance fees, and does not have any commitment beyond to be a member for more than a year. Campgrounds in the member network are individually owned and operated. In exchange for the annual membership fee, you are allowed to camp at member campgrounds at a predetermined rate or a

percentage of the full rate (usually 50 percent).

Reservations may or may not be taken. All sites are available for the discounted rate if vacancies are available. However, some discount networks have blackout dates when the discount rate does not apply. For popular snowbird areas, this may be the entire winter season. *Passport America* and *Recreation USA* are examples of discount networks and they will typically have 300 to 800 member parks.

Before You Join

Extreme care should be exercised when joining a campground association or a membership club, as you are usually obligated to pay dues and maintenance fees for a minimum number of years unless you sell your membership. Like timeshares, resales usually net a small fraction of your initial investment, and the purchaser may have to pay a substantial "transfer

Before you join any campground membership club, make sure that the campground system has campgrounds where you are likely to travel and take advantage of their facilities. Are you willing to possibly go out of your way to stay at a member park? Are you willing to make reservations, often far in advance, to ensure that you have a site?

fee" to join the organization. Also,

over time, the annual dues and main-

tenance fees may be increased, and it is

important to understand the terms and

conditions of these increases.

You will also want to make sure that the company that owns the campgrounds in a membership club is financially viable, as you will lose your investment if they go bankrupt.

We have been full-timing for more than five years and have investigated many of the options described above. For us, the only options that make economic sense are the discount campground networks.

RV Safety Tip

hen considering the purchase of a new RV, ensure that it has carrying capacity to match your requirements.

Although you may not be able to find a place to weigh it wheel by wheel, weigh each axle, then evaluate the location of storage areas, liquid tanks, major appliances, slide-out rooms,

generator, LP gas tank, etc., to see if the distribution of these heavy components makes sense.

You must have a good knowledge of your personal weight carrying requirements. A few helpful figures are the following pounds per gallon:

Water – 8.3 Gasoline – 5.6 Diesel Fuel – 6.8 Propane – 4.2

As you calculate your requirements, keep in mind that *everything* you put in the RV has weight. The average couple carries approximately 2,000 pounds of "stuff," while the average full-time couple carries an average of 3,000 pounds.

Remember: selection of the proper RV for your unique needs is *your responsibility*. When you buy a pair of shoes, you don't buy an 8 if you wear a 10. Know what your "size" (carrying requirement) is *before* you start shopping, and verify that the proposed RV meets your needs.

Tips to Prevent Identity Theft

friend of Don Fuller's forwarded the following, commenting that while we've probably heard these tips before, it's a good idea to refresh our memories so we can protect ourselves.

Identity theft and account fraud are making headlines. Identity theft happens when someone steals personal information such as your bank account number or Social Security number, and then poses as you, either cleaning out your account or running up debt in your name, or both. The threat is real, and the government estimates 400,000 people are victimized by these crimes each year.

Maximum security is possible only with your help. Here's what you can do to stop identity theft before it happens, and protect your assets and your good name.

* Don't give out financial information such as checking and credit card numbers – and especially your Social Security number –

on the phone unless you initiated the call and know the person or organization you're dealing with. Don't give that information to *any* stranger, even one claiming to be from your bank.

- Report lost or stolen checks immediately. Your bank will block payment on the check numbers involved. Also, review new deliveries of checks to make sure none has been stolen in transit.
- 3. **Store** cancelled checks and new checks in a safe place.
- Notify your bank of suspicious phone inquiries such as those asking for account information to "verify a statement" or "award a prize."
- Guard your ATM Personal Identification Number and ATM receipts. Thieves can use them to access your accounts.
- 6. Don't throw away financial solicitations that arrive in your mailbox. Tear them up so thieves can't use them to assume your identity. Tear up any other financial documents such as bank statements or invoices before disposing of them.
- Don't put outgoing mail in your mailbox. Drop it into a secure, official Postal Service collection box. Thieves may use your mail to steal your identity.
- 8. **If regular** bills fail to reach you, call the company to find out why. Someone may have filed a false change-of-address notice to divert your information to his or her address.
- If your bills include suspicious items, don't ignore them. Instead, investigate immediately to head off any possible fraud before it occurs.
- 10. **Periodically** contact the major credit reporting companies to review your file and make certain the information is correct. For a small fee you can obtain a copy of your credit report at any time. The three major credit bureaus are: Equifax (800.685.1111), Experian (800.682.7654), and TransUnion (800.916.8800). According to some state laws, you are eligible to receive a free copy of your credit report annually from these services.

Follow these tips and you can head off identity theft and account fraud before they ever happen.

Discovery Modifications

The humans are a changeable species. We no sooner purchase the home (or motor home) of our dreams, but what we begin to change it, re-arrange it, alter it, do stuff to it...we modify! This is the first of a series of articles featuring the interesting things DOAI members have done to their rolling homes, large projects and small projects and everything in between. And we want to hear from more of you who have turned a crafty and talented hand to the task.

This issue we feature a series of modifications Bob Baugh has made to his 2003 39P with two slide-outs. In the next issue we'll feature modifications done by Peter Shaffer, and we have Carl Dykman and others waiting in the wings. With each presentation, please don't hesitate to contact the member for more detailed information...and happy modifying!

Bob writes: Although I have not made any original modifications to my coach, as almost all the ideas were stolen from someone else, here are a few of the things I believe have added to the livability of our "D."

The first and easiest modification was to add small shelves behind the loveseat and couch. There was no place to put a drink while sitting at either site. The shelf behind the loveseat is full length of the window with two cup holders which were routed out with cork inserts (see photo 1). The small shelf behind the couch is short and fits behind the indentation on the back. This allows the couch to open and close for sleeping, with no interference from the shelf. I also added a magazine rack with small drawer and cup holder at the end of the couch behind the driver's seat (see photo 2). None of these interfere with the normal use of the coach, and are very convenient when sitting, watching TV, or visiting with friends.

In the kitchen area, we had an open space with a door under the counter. In this area I placed a sliding three-shelf tray for storing canned goods (A in photo 3). As originally designed, this space was almost useless. Also under the counter and between the new sliding

tray and the doors under the sink, I removed the facing and inserted three small drawers (9" by 14", B in photo 3). These are very nice for storing spices, condiments, etc., and create a significant amount of cabinet space.

In the bedroom, under the three drawers built below the corner TV, I added two more drawers (D and E in photo 4, next page). These are short,


only 11" deep, as they must fit in front of the water heater. To create these drawers, one must cut out the drawer openings in the wall paneling, but these have already been framed into the original design. The extra drawer space is extremely beneficial for increasing bedroom storage.

Since we never use the table insert when dining, I modified it to make a fold-down shelf that works nicely for holding our laptop computer. The shelf folds down against the wall when not needed (see photo 5).

None of these modifications were difficult to do. As I stated in my last president's message (see Winter 2003-2004), getting the motivation and courage to make that first cut is the hardest. The woodwork in my coach has the light maple finish, and can easily be matched with hard maple wood covered with a clear,



More About Fraud ollowing on the heels of that ♦ helpful article on page 18 about preventing identity theft, is this cautionary tale.

One of the more prevalent frauds being perpetrated today takes place when one is selling an item which is supposed to be shipped to the purchaser, or to the purchaser's representative, and paid for by a check which considerably higher than the selling price.

The following actually took place recently via the DOAI website: An individual (who is not a DOAI member) advertised a set of wheels and tires for a Discovery for \$950. He was contacted via e-mail by a party wishing to purchase them. The purchasers said they were from the UK, and had a

container shipping soon and wanted to include the wheels and tires in the shipment. They advised the seller he would receive a certified check for \$6,000, and then asked the seller to wire the balance of \$5,050 to the designated shipper to pay for the freight. He was further advised the shipper would make arrangements to pick up the wheels and tires.

The seller thought it was a rather strange request, but felt it might be legitimate since, according to him, the only place he had advertised the items was on the DOAI website. He received the check, and then decided that a bit of caution was in order. Before he sent the money, he checked with his bank manager. Sure enough, the check was bogus.

The seller, of course, didn't take

RV Safety - Hidden Hazard of the Road by RV Alliance

s a traveler, you're familiar with the usual hazards of life on the road, such as rain, ice and fire; but did you know that sitting for long periods can also be hazardous? Studies show that an extended duration of immobility can lead to a condition called Deep Vein Thrombosis (DVT). When a person sits or lies still for a prolonged period of time, blood thickens, which can lead to clots in the veins.

Statistics show approximately two million people, and possibly more, are afflicted each year - particularly people over the age of forty, women taking estrogen, those with varicose veins, those with family history of blood clots or DVT, pregnant women and anyone recovering from recent surgery or a condition that required they be immobile for any period longer than a

Medical research shows that about half of people afflicted with DVT experience no symptoms. The other half sometimes experience a swelling and warming in the tissues of the legs, a sore tenderness in the veins of the legs and/or pain when standing or walking. These symptoms can occur up to two weeks after a long drive or period of immobility. If you are experiencing any of these symptoms, see a doctor as soon as you possibly can.

In more extreme cases of blood clots in the lungs or other vital areas, symptoms may include shortness of breath and/or chest pain. If you

the matter any further, but wants each of us to be alert for scams such as this. As he wrote, "I can see where someone can get taken very easily, because the scam artist was contacting them about something on the DOAI website, which might give the scammer a bit of credibility."

On a personal note, my response was that if anyone offered to send me a check for several thousand dollars more than the selling price, expecting me (a stranger) to be honorable and send the balance to another party, it would immediately cause an alarm to go off in my head. This scam is very similar in ultimate intent to those bogus e-mails you may have received from someone in a Third World country needing to transfer huge sums of money "to your bank account."

experience these signs, call 911 immediately. Waiting to see a doctor can cause the condition to worsen and put your health at serious risk.

Fortunately, blood clots are highly treatable once detected. If diagnosed, your doctor will likely prescribe an "anticoagulant," or blood thinner, to break up any clots that may be forming. If you have a serious incident, a hospital stay will probably be on the agenda.

While this condition can be very dangerous, by being aware of it and taking some simple precautions, it is easily preventable.

- Drink plenty of fluids. Dehydration can cause a thickening of the blood and a higher risk of blood clots.
- Avoid caffeinated drinks and smoking these can also contribute to thickening of the blood.
- Avoid crossing legs when seated.
- Wear loose-fitting and comfortable clothing when you know you'll be driving a long distance.
- Taking aspirin may help thin the blood and counteract clotting. Consult your doctor to ensure that taking aspirin for this purpose is recommended.

- If you are concerned or your doctor has assessed you are at risk for DVT, you can purchase special stockings called compression or anti-embolic stockings; these are often covered by medical insurance. The stockings assist the natural function of your veins by offering mild graduated compression, improving the return of blood to the heart.
- Most importantly, get up and move around for a few minutes every two hours or so. If it's not possible to stand and move around, see the illustrations following for some in-your-seat exercises for RV passengers and the driver when the RV is parked (courtesy of United Airlines).

Because being out of your seat belt while the vehicle is moving is a safety hazard, stop the vehicle when you need to move around. If you have the option, share the driving responsibilities with your traveling companion. Driving doesn't leave much room to move, so stop at roadside attractions or rest areas and stretch or switch drivers every two to three hours. Making a routine out of stopping regularly for a little exercise can keep you healthy and make your trip more enjoyable.

Lift your knee as far as you can up to your chest (Figure 1). Repeat with other knee. Then straighten knee (Figure 2), increasing the amount of joint space at the back of the knee to its full range. Repeat with other leg.

With your heel resting on the floor, point your toes upward (Figure 3). Repeat with other foot. With your toes resting on the floor, lift your heel upward (Figure 4). Repeat with other foot. With the ball of your foot on the floor, gently swing your heel out, rotating on the ball of your foot so your toes are pointing toward each other (Figure 5). Do this with both feet at the same time or one at a time. Reverse the last exercise: leaving the ball of your foot on the floor and gently swing your heel inward, leaving your toes pointing away from each other (Figure 6). *Illustrations by David Navascues*.
